## **Metropolitan Opera Ratifies 3-Year Agreement**

On September 16, 2011, the musicians of the Metropolitan Opera Orchestra ratified a three-year agreement that runs from August 1, 2011 and continues through July 31, 2014.

After many years of successful early contract negotiations the Met Opera Orchestra, this year, faced a negotiation at the deadline of the expiration of the old agreement. Management had begun putting forward concessionary proposals, and the committee realized a favorable resolution would not be possible without the threat of a work stoppage. Each orchestra member had set aside considerable savings for this eventuality, and as the date approached, the orchestra was mobilized for the possibility of a lock-out - picket lines were organized, signs and leaflets were printed, permits were secured, and the support of the other unions at opera house was obtained. In the end, at 2:30AM, they were able to achieve a fair contract in the context of current economic conditions.

A federal mediator attended the final two days of negotiations, but on the final day, management requested the presence of the current director of the Federal Mediation and Conciliation Service, and former AFM General Counsel, George Cohen. Thanks to Director Cohen's skillful work with both parties, they achieved a satisfactory agreement.

**INSURANCE**: Out of pocket reimbursement percentage was reduced from 80% to 70%. In-network co-pays

increase to \$15 or \$25 per visit [WAS: \$10].

**WORKING CONDITIONS**: There were minor improvements in rehearsal break times.

#### **MISCELLANEOUS:**

- The Librarians' extra service rate increased.
- The Librarians' vacation time was increased to 10 weeks to match the players' vacation time.
